BY-LAW NO. 1658-96

BY-LAW TO DESIGNATE THE SNIDER HOUSE, IN THE TOWNSHIP OF NORTH DUMFRIES, TO BE OF HISTORIC AND ARCHITECTURAL VALUE AND INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1990 authorizes Council of a Municipality to designate property within the Municipality to be of historic value or interest;

AND WHEREAS Council for The Corporation of the Township of North Dumfries deems it desirable to designate the Snider House, built in 1874, to be of historic and architectural value and interest;

AND WHEREAS the Clerk of the Township of North Dumfries has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1990;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1990.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF NORTH DUMFRIES ENACTS AS FOLLOWS:

- I. The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.
- Section 33 of The Ontario Heritage Act, R.S.O. 1990 shall apply only to the inside front door, the decorative structure around the outside of the front door, the ceiling and frame on the underside of the verandah and the porch posts.
